Enforce rules: Limit swings to knee height, maintain 1-meter distance between players, and cap groups at 4 per hole. Provide scorecards to track shots and enforce a 6-shot limit per hole to prevent frustration-related incidents. adults remain responsible for accompanying minors Reserve the right to remove equipment from players behaving dangerously. Inspect courses for hazards before play. - Wear appropriate footwear with good traction. - Signpost hazardous areas on the course. - Encourage players to move cautiously around obstacles. - Mark hazardous obstacles clearly. - Provide first aid kits on-site.
